NATIONAL NEWS

STATE CONVENTION 2013

National and State dues must be paid 30 days prior to the State Convention for a court to be entitled to representation. Courts shall elect delegates to the State Convention at a business meeting preceding the deadline for submitting delegate registration to the State Regent (Bylaws, page 36).

If you do not have court meetings in January or February, please elect your delegates and alternates at your <u>December meeting</u>. This will insure that your court will have representatives at this important event. All are welcome to come to the convention, but only those elected as a delegate will be able to vote. You will be notified by National as to the number of delegates and alternates your court is eligible to have after November 15, 2012.

EDUCATION CONTEST 2013

The rules and regulations for the 2013 contests were sent to you in your September National Update. If you have any questions, please contact your State Chairman for clarification.

FALL FINANCIAL REVIEWS

The Fall Financial Review was due on November 1. If your court has not completed this review, please do so as soon as possible.

2013 National Education Contest

The 2013 National Education contest themes are: "JESUS IS REFLECTED IN ME" and "MY LIFE IS A REFLECTION OF GOOD." First, each local court should make a supreme effort to sponsor the Education Contest. The themes selected this year encourage lively imagination and freedom of thought when students' talent and application go hand-in-hand.

Our contest is open to our communities' schools and CCD classes to compete and strive for awards while following certain guidelines.

The choice of categories is: ART, ESSAY, POETRY, COMPUTER ART, MUSIC and PHOTOGRAPHY.

Adult CDA members may submit entries in **POETRY**, **ART**, **COMPUTER ART and PHOTOGRAPHY**.

The local court will decide the amount of the prizes to be awarded to the first three winning entries in each division within each category.

Once the panel of judges has picked the winners, plan a special event, invite the parents, teachers and principal. Take pictures, write an article and send it into the local newspaper, showing the winners and their awards. You could have an ice cream social or a pizza party.

The most important thing to keep in mind are the RULES:

ESSAYS are not to exceed 500 words.

POETRY must not exceed 8 lines.

ART must be 12" x 18" with NO LETTERING

COMPUTER ART must be $8^{1/2"}$ x 11" with NO LETTERING.

MUSIC must be the contestant's own creation, on a CASSETTE or CD only. If you are using a tape format, please make sure to punch out the tabs on the tape to prevent accidental erasure.

And, lastly, **PHOTOGRAPHY** must be an $8'' \times 10''$ picture depicting the theme. It can be color or black and white. NO collages.

Entries will be disqualified if rules are not followed.

ENTRIES MUST BE SUBMITTED TO STATE COURT CHAIRMAN AND MUST BE **POSTMARKED NO LATER THAN MARCH 15, 2013.**



Excerpts from Presentation by State Chaplain

Father D. Timothy Grimme State Workshop 2012, State College

From the National Chaplain's Keynote Address

- ◆ The chaplain of the court is the "Internal Anchor." Be rooted in God's grace, love and faith. This is expressed in the chaplain being present.
- ✦ He/she is to show the attitude of gratitude. This gratitude recognizes God working through the court and their activities.
- ✦ He/she is the keeper of the Vision AND the communicator of the Vision. The chaplain draws the connection between faith values and court values.
- ◆ Don't depend on your influencing of others; God is with us through them. Do not foist spirituality on the court; rather share your own with the court and embrace the court's.

Encourage Courts to Have a Ministry

- ♦ Beyond the court or parish. [Give knowledge of what is beyond the court through attending and encouraging attendance at Diocesan, State and/or National level events...workshops, conference and conventions.] Reach out—encounter the world with Christian values.
- ♦ Encourage members to ask every Catholic woman they know to join CDA; REMEMBER one membership drive per parish to which members belong (and don't forget about parishes without courts).
- ♦ Have FUN at meetings (parties, picnics, fashion shows, card parties), non-fundraising meetings. Each court should develop their own particular style of FUN.
- ◆ Assist (offer to assist) to make parishes more spiritual. Lay leadership in devotions [at my parish someone wanted to start Sacred Heart Devotion. They expected me to lead them. I declined. It is only truly their devotion if they lead it; priests will come and go.]

Involvement

PRESENCE at meetings; impress on officers the importance of continued spiritual growth; give advice in program planning and at court meetings.

Activities with Chaplain

Includes Eucharistic planning (along with installations and reception of members); arrangement for annual Memorial Masses or services in memory of deceased members; vigil services of members (and relatives of members) [funerals?]; arrange days of spiritual renewal [retreats, public forums, lecture series] with the Spiritual Enrichment chair; give advice to membership regarding controversial and moral issues. Exchange ideas if possible with other chaplains.

Conclusion

The chaplain is afforded the opportunity to work with Catholic women, to listen to them as well as inspire, direct and instruct them. The underlying thought is that the chaplain's role is one of spiritual guidance, helpful advisor and consultant.
